

I. A - NSAA district boundaries will be reviewed at least every 10 years, and more frequently if the need exists. -- This is a change from the current every 4 years. (Yearbook)

I. B - Any student entering high school for the first time after promotion from grade eight who did not initially enroll in the high school located in the school district where the student's parents have their domicile, or a student who transfers back to a high school located in the school district where his/her legal parent(s) have established their domicile shall be ineligible for ninety school days. (Yearbook)

I. C - Adds another definition to the volleyball competition points section. (7) Three team-Dual/Triangular Match 1 or 2 points.

II. A - Adds another bullet point for ineligible (because of non-compliance) - Students who are ineligible for varsity participation due to transfer or eligibility rule non-compliance may participate at the non-varsity level at varsity competitions as long as the activity does not involve physical contact or personal/team gain in points towards varsity competition.

II. B - Eight Man football would have 8 game schedule in 8 weeks (no byes). Playoffs would start on Thursday of NSAA Week 16 (same week as other classes Week 9 games). Playoffs would then go Friday, Friday, Friday (Weeks 17, 18, 19) with the finals being played on Monday of Week 21.
