

# Order Form Ticket Process

The contact person on the order form will receive all tickets electronically to the email address on the form. They must create a Ticketmaster account using the email listed in order to receive the tickets. Use this link to sign in or create an account: <https://am.ticketmaster.com/CHI>

- You must have a Ticketmaster Account or create one to purchase or accept tickets.
- You can transfer tickets via email, but the person accepting the tickets must have a Ticketmaster account with that email or must create one with that email.
- They will get an email telling them that they have received tickets and will give them a link to accept them.
- Once they click that link, they will be directed to a page where they will need to login to their Ticketmaster account. If they do not have an account, they will need to create one with the email that they received the tickets on.
- Once they accept the tickets, the person who transferred them will receive a confirmation email saying that the transfer was completed.
- Tickets can be printed physically and distributed.
- Your electronic ticket can be saved to your Apple Wallet or Google Pay.
- Tickets can be transferred more than once.
- If you have multiple Ticketmaster Accounts, make sure you are logged in to the one you want to accept the tickets on. If you are logged into the incorrect account when accepting tickets, they will not transfer to the correct account.
- The transfer can be cancelled by the sender until the recipient accepts them.
- Printed or Electronic Tickets can only be redeemed once. Once that code is scanned, it will not work if someone else tries to use it.
- Purchasing your tickets online through Ticketmaster gives you a reserved seat. There is a \$4.35 fee per ticket, and a \$4.25 fee for each order regardless of the number of tickets being purchased. Purchasing tickets at the box office will not have the fees and will just be the price of the ticket.
- Tickets will be able to be purchased prior to the event or on the day of.
- Tickets for different sessions will have to be purchased separately. Multiple sessions will not be able to be purchased at once. They will have to be on a separate order.

## 2022 STATE WRESTLING CHAMPIONSHIP GROUP TICKET ORDER

**PLEASE NOTE:** When ordering for a group, SEND ONE ORDER FORM AND ONE CHECK. Ticket orders will be filled in the order of the random drawing done on December 3, 2021. All tickets for each session are for specific seats for that session. Tickets for the two Thursday sessions and the two early Friday sessions are \$8. Some seats are in the preferred seating areas for Friday Night Semifinals and Saturday, some are not, but are in the Upper Bowl End Zones. Preferred seats for those two sessions are \$10; Upper Bowl End Zone seats for those two sessions are \$8. All of the tickets needed to attend the Wrestling Championship may be purchased by using this form. Check or money order, plus \$6.50 CHI Health Center Omaha handling fee, must accompany ticket orders. No refunds will be made on tickets. Mail orders will not be filled after January 1, 2022. **Preferred Seating will extend into the upper bowl.**
