

2019 STATE WRESTLING CHAMPIONSHIP TICKET ORDER

PLEASE NOTE: When ordering for a group, SEND ONE ORDER FORM AND ONE CHECK. This will ensure quicker handling and mailing of your tickets. Ticket orders will be filled in the order of the random drawing done on Dec. 7, 2018.

All tickets for each session are for specific seats for that session. Tickets for the two Thursday sessions and the two early Friday sessions are \$7. Some seats are in the preferred seating areas for Friday Night Semifinals and Saturday, some are not, but are in the Upper Bowl End Zones. Preferred seats for those two sessions are \$9; Upper Bowl End Zone seats for those two sessions are \$7. All of the tickets needed to attend the Wrestling Championship may be purchased by using this form. Check or money order plus \$6.50 CHI Health Center Omaha handling fee must accompany ticket orders. No refunds will be made on tickets. Mail orders will not be filled after January 1, 2019.
